Which data we collect

We collect the data that you fill in when making an order: your name and surname, your address, your email address, and your telephone number. You enter this data when you make an order. You make orders only as guest. We do not ask you to make an account and log in in order to place orders.

What do we do with your data

We use your data exclusively for processing your order. We do not produce a newsletter, neither send any individual messages other than for arrangements regarding the delivery of your order and only when this is necessary.

With whom do we share your data

We share your data with the platform of the webshop, which is webwinkel.nl and with the payment company, which is Mollie. We use Google Analytics which means that Google can access your data. However, it will not store it: Google Analytics is a third-party information storage system that records information about the pages you visit, the length of time you were on specific pages and the website in general, how you arrived at the site and what you clicked on when you were there. These cookies do not store any personal information about you eg name, address etc and we do not share the data. We have buttons for Facebook, Pinterest, Twitter, and LinkedIn, which means that these social media platforms can also access your data. Webwinkel.nl has confirmed that your data is protected against leakage and misuse. We will keep on checking with them to make sure that this remains valid.

We will also share your data partially (name, address, ordered items and amount paid) with the tax office should that be requested for our finance control (under Dutch law).

We do not share data with international persons, companies, or organisations.

We do use cookies for optimal functioning of the website and for personalised search when you revisit the website. There is a banner when you open our website where you are asked to agree with the use of cookies; on the same banner you can click on the information about what cookies are and how they are used.

How long do we keep your data

We will keep your data for 7 years, only to comply with the tax office requirements.

Access to your information, correction, portability and deletion

What is a Subject Access Request?

This is your right to request a copy of the information that we hold about you. If you would like a copy of some or all your personal information, please email us to atelier.kapnos@gmail.com. We will respond to your request within one day.

We want to make sure your personal information is accurate and up to date. You may ask us to correct or remove information you think is inaccurate by emailing us to the same address.

Objections to processing of personal data

It is your right to lodge an objection to the processing of your personal data if you feel the “ground relating to your particular situation” apply.

Data Portability

It is also your right to receive the personal data which you have given to us, in a structured, commonly used and machine-readable format and have the right to transmit that data to another controller without delay from the current controller if:

- (a) The processing is based on consent or on a contract, and
- (b) The processing is carried out by automated means.
