Orders less than 15 kg will form part of a consolidated order that will be placed twice per month and shipped to the Netherlands.
Orders less than 15 kg may be placed in the following weeks of the month:
In the last week of the month - orders are shipped in the first week of the month
In the second week of the month - orders are shipped in the third week of the month

Orders of more than 15 kg will be sent direct to you and may be placed at any time during the month.

How to place an order:

Orders can be placed by mail. Please state colour name or code and amount of packets required.
From 1 March 2016 our new secure wholesale website will be available for placing orders online. Please contact Michelle on info@scaapi.nl to obtain your log in code. Please provide your company name and details as well as your VAT registration number.

Payment terms:

100% upfront payment by bank transfer unless communicated otherwise.

Lead times:

The lead time on all yarns is between 2 -3 weeks (from date of order received till delivery)

Minimum order requirement:

The minimum order requirement per supplier is stated on each price list next to each article description. Please note that the minimum can be spread across qualities and colours per supplier.

Return policy:

If you make a mistake and order the incorrect colour, we are able to rectify this for you at a minimal charge of 5 Euro if the order has not been shipped from South Africa. If your order has been shipped, we are unable to change your order and the yarn will be sent to you.

Should there be a colour missing from your order, we will make sure you receive it asap free of charge.

Transport cost:

All wholesale prices include transport from South Africa to the Netherlands. Orders of more than 15 kg can be sent direct from South Africa to your shop by courier (UPS or DHL) DDP so you pay no duties nor taxes.

Orders less than 15 kg will be sent to the Netherlands first along with all other small orders from other shops. Your order will then be sent to you from the Netherlands by Dutch postal service. Standard postage (including track and trace code) from the Netherlands will be added to your invoice. The postage that will be added can be seen here below:
