By placing an order, you agree to these terms.

Exceptions to the general conditions are valid only if expressly and in writing with Meertax agreed, in which case the remaining provisions shall remain in force.

Meertax always reserves the right to change the terms and content of the website to modify and / or supplement. In particular, when under (legal) regulations.

Price

The prices for the products and services are in Euro`s, including 6% VAT and including postage and packaging, unless otherwise indicated.

Order

The agreement is concluded at the moment you through the online store of Yvonne Hakkert .NL a final order. After your order you will receive a confirmation with the total costs and further information. When placing your order you must take care to specify the correct delivery address. Should the article unfortunately no longer in stock and / or the delivery so different from the delivery being generated, we propose this within five working days, informed by e-mail or telephone. If the article is not available / sold out, will the contract be dissolved by Meertax. Any payments in this case of course returned.

Pay

The payment covers the full purchase price and any shipping costs. Prices are subject to errors. When ordering, you choose from the following two payment options:

- 1) Pre-pay. You can pay by bank / giro transfer prior to bank Meertax account Amsterdam stating the order number you have acquired. Upon receipt of your payment the items in compliance with the specified delivery made (applicable to custom), sent or delivered via conveyor.
- 2) Payment via Mollie. Through Mollie you trusted, secure and easy online purchases. There is no extra charge. After receiving your payment we will send you a confirmation e-mail and the articles are in compliance with the specified delivery sent or delivered via conveyor.

Delivery

Once payment is received by us, we will arrange for the shipment of your order. Usually applies to a delivery of 7 days (unforeseen circumstances, weekends and holidays not including). Meertax also depends on delivery time of printing. You can therefore continue to guide the delivery which `explicitly` in the product are listed.

Should the article unfortunately no longer in stock and / or the delivery so different from the stated delivery time, we propose this within five working informed by e-mail or telephone. If the article is not available / sold out, will the contract be dissolved by Meertax. Any payments in this case of course returned.

Delivery by mail (package)

All packets are sent with an external printer as the default package. Meertax depends on it and is not financially liable to stellen. Ofcourse Meertax will ensure that you receive your order to your satisfaction. TNT Post offers the mission once, even on Saturdays. If you are not present, then let TNT Post a takeaway message that allows you to 3 weeks of your order at the nearest post office to collect.

Output per transport

The articles are delivered to your address given by you during the webshop order.

Liability

For the consequences of typing and printing errors can Meertax not accept liability. This also applies to any programming errors on the website.

Your order will be with the utmost care and in good condition to be delivered to an external printing / TNT. Shipments are always at risk of the buyer. Meertax is not liable for delay of delivery by TNT.

derive any rights.

Returns

Because Meertax has to pay the printing costs and shipping costs to an external printshop after your order is placed Meertax is forced to process your order as final.
